
1. The current Complaint lists two individuals as the Respondents.

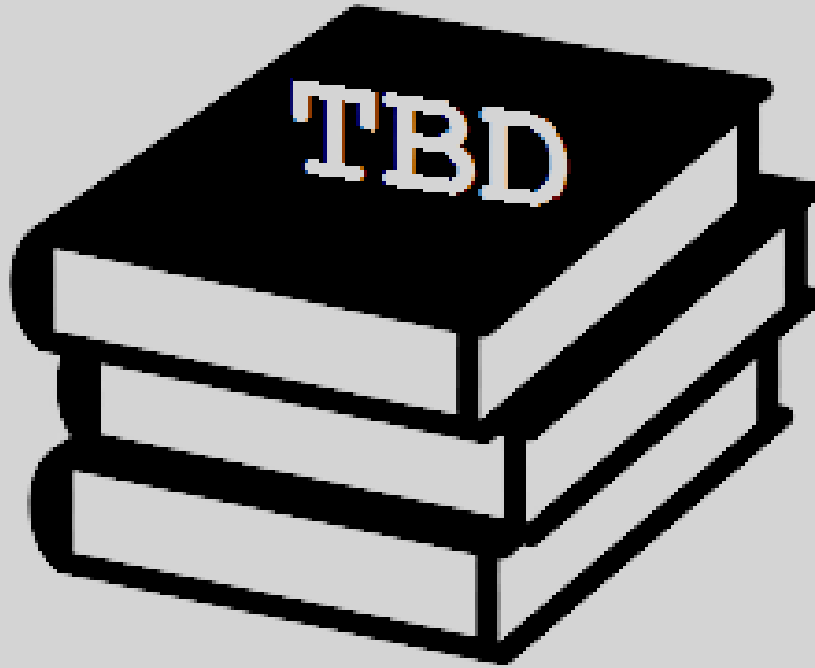
