**MOTION FOR REHEARING/CLARIFICATION AND NOTICE OF THE
COMMENCEMENT OF SUSPENSION**

COMES NOW, Stephen A. Schorr, by and through his undersigned counsel and files this Motion for Rehearing/Clarification and Notice of Commencement of Suspension and states as follows:

1. This Court entered its Order on January 28, 2016 approving/ordering the 30 day suspension for Mr. Schorr.
2. The Order allowed Mr. Schorr thirty (30) days to close down his practice and permitted him to notify the Court that he did not need that time and for the suspension to begin immediately. Mr. Schorr, hereby notifies the Court that he will have his practice closed down on or before February 14, 2016 and will begin his suspension with this Court's approval, on February 15, 2016.
3. Further, in its Order, this Court imposed a judgement for costs against Mr. Schorr.
4. The Referee in this matter executed the Report of Referee Accepting Consent Judgment (Tab 10 in the Index of Record) which in Section IX acknowledged that Mr. Schorr had already paid all of the costs incurred and that a judgment for costs should not be entered. Therefore, there should not be a judgment for costs against Mr. Schorr for any amount.

5. The undersigned has notified The Florida Bar of this issue and has been informed that The Florida Bar agrees that there should not be any judgment entered against Mr. Schorr as it has already been fully reimbursed for its costs in this matter.

WHEREFORE, Mr. Schorr prays that this Court grant the rehearing and enter an Order without the judgment for costs and acknowledge that Mr. Schorr's suspension will begin on February 15, 2016.

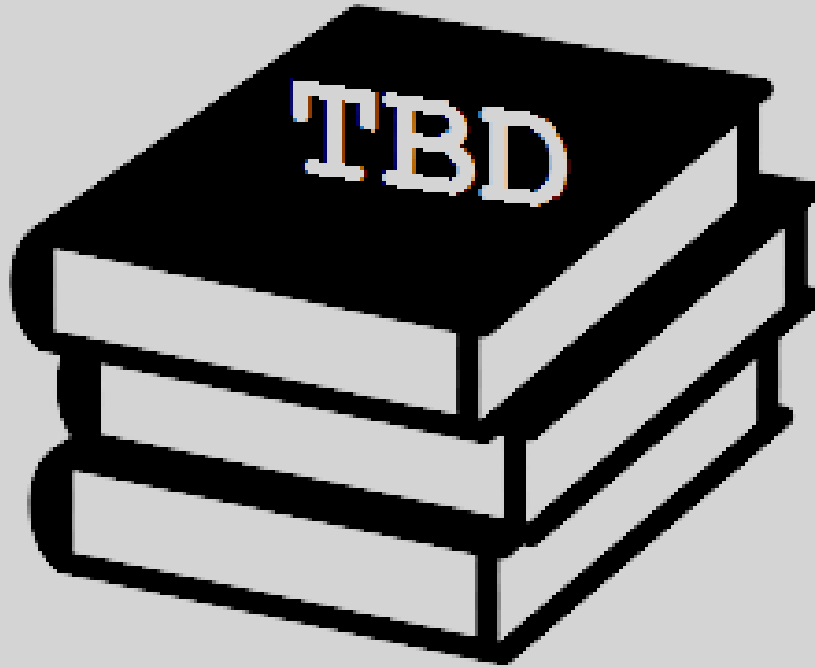
