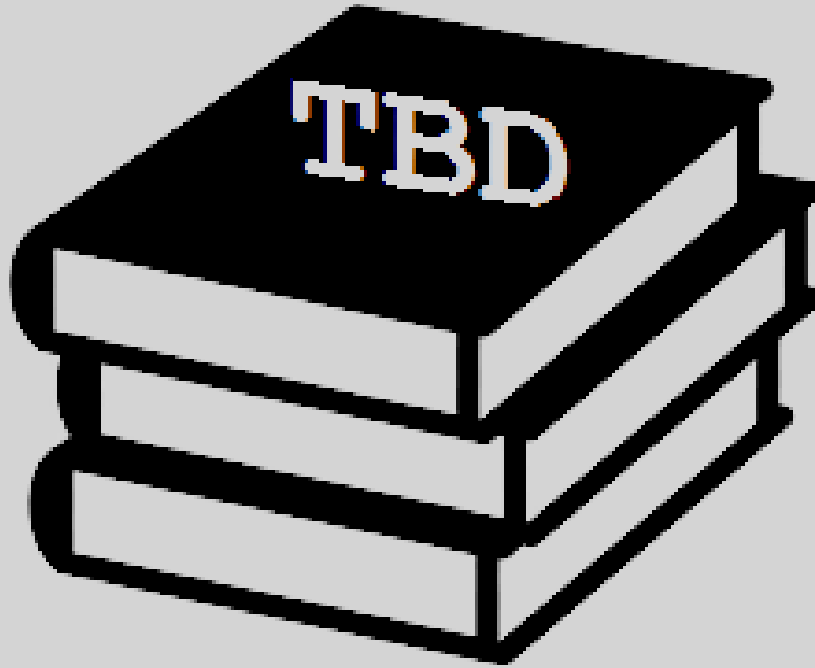

PETITION FOR WRIT OF QUO WARRANTO

The Petitioner named above, ALPHONSO JAMES SR., applies pursuant to Article V, Section 3(b)(7)(8), Florida Constitution, for a Writ of Quo Warranto directed to the respondent named above, Rick Scott, Governor, Respondent.

I.

Tallahassee, Leon County, Florida is the Office of the Governor duly organized and existing under and by virtue of the laws of the State of Florida. By the same laws, there has been created and exists in the Office of the Governor power to see the laws are faithfully executed, and the purpose to secure protection to life, liberty and property of the inhabitant of the State, of the Office of the Governor.

II.

On October 12, 2015, a "NOTICE OF INQUIRY/STATUS REPORT," was filed pursuant to a "PETITION" filed/mailed on August 25, 2015, to the Respondent Rick Scott, Governor, from Petitioner

ALPHONSO JAMES, SR., See *Exhibit A*. Since that date Respondent Rick Scott, Governor, has failed to initiate judicial proceedings in the name of the State against any executive or administrative state, county, or municipal officer to enforce compliance with any duty or restrain any unauthorized act. Art. IV, § 1(b), Fla. Const., and would not exercise the office pursuant to the petition at *Exhibit A*, which show the laws was not faithfully executed as implemented by statute, Section 944.17(5)(d), and will continue to do so unless the requested relief is granted, as such it is the Governor authority under constitutional provision that it is the duty of the Governor to take care that the laws be faithfully executed as implemented by Statutes relating to power of the governor, which is essentially what the Department of Criminal Law Enforcement Act of 1974 is designed to achieve, derives from this section pertaining to powers and duties of the governor. Thompson v. State, 342 So.2d 52 (1976). Advisory Opinion to the Governor, 200 So.2d 534 (1967).

Wherefore, Petitioner requests that a Writ of Quo Warranto be issued by this Court directed to Respondent, Rick Scott, for the relief sought above, and for any other and further relief as the Court may deem proper.

In an action of exhausting administrative remedies with the Department of Corrections that has no authority to hold petitioner James' because his Uniform Commitment to custody paperwork was allegedly incomplete or defective, no sworn complaint, or probable cause affidavit. See Exhibit-A, also see Case Number 15-205 CA.

Briefly, the argument of the undersigned concerning Department of Corrections should have never accepted petitioner James' into state correctional system because the Uniform Commitment is not in compliance with Section 944.17(5)(d), because the probable cause affidavit was not transmitted to the Department of Corrections along with the Uniform Commitment.

That the Department of Corrections is restraining Petitioner of his life, and liberty, because Uniform Commitment to custody paperwork is "VOID" of a probable cause affidavit, and no sworn complaint.

That the Department of Corrections also in case no. 89-1711CF, Uniform Commitment to Custody paperwork is "VOID" of a probable cause affidavit, and no sworn complaint. See Exhibit-B, the Dept. of Corr., should have refused to accept James' in violation of 944.17(5)(d) which states: "Chapter 944. STATE CORRECTIONAL SYSTEM 944.17, Commitments and Classifications; transfers. (5) The department shall also refuse to accept a person into the state correctional system unless the following documents are presented in a completed form by the sheriff or chief correctional officer, or a designated representative, to the officer in charge of the reception process: (d) A copy of the probable cause affidavit for each offense identified in the current indictment or information." 944.17(5)(d), Fla. Stat..

That the Department of Corrections should have refused to accept James' in the above case numbers 89-890CF, and 89-1711CF, because there is no probable cause affidavit transmitted to the Dept. of Corr., along with the Uniform Commitments at Exhibits A and B.

That Article IV Executive Section 1 Governor States:

(b) The governor may initiate judicial proceedings in the name of the State against any executive or administrative state county or municipal officer to enforce compliance with any duty or restrain any unauthorized act.

The above Statutes and Constitution Article IV Section 1 (b) Florida Constitution come to the aid of the undersigned.

WHEREFORE: The petitioner herein, undersigned, respectfully petitions the Honorable Rick Scott, Governor of the State of Florida, to "maintain and defend its petitioner" against the blatant and incessant encroachment of the Florida Department of Corrections.



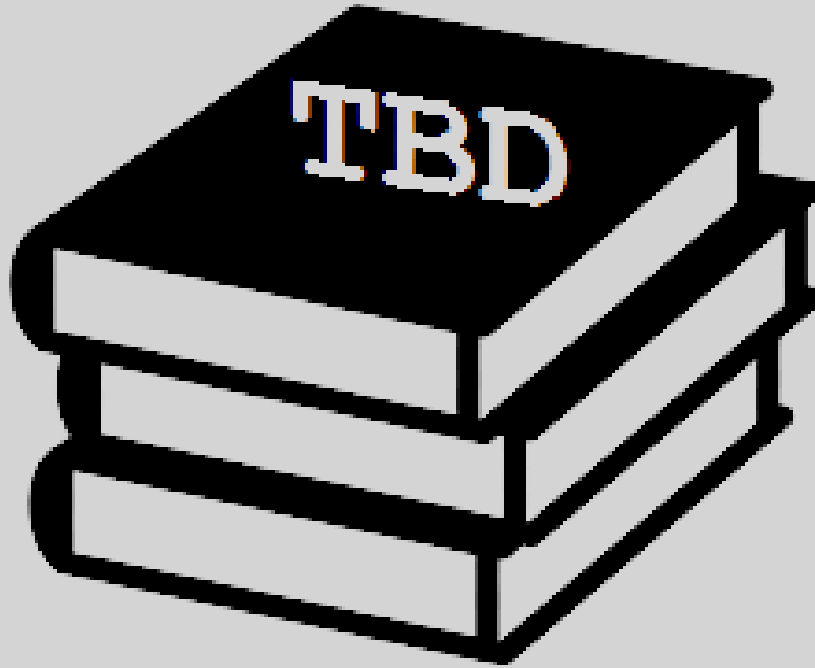
