JOINT MOTION TO MODIFY SUPREME COURT ORDER

COME NOW, The Florida Bar, and Respondent, by and through undersigned counsel, and together move this Honorable Court to modify the Order in this case as more fully explained below.

1. At the time of the consent judgment, Respondent had not yet been sentenced.
2. After the consent judgment and the Report of Referee, Respondent was sentenced in his federal case on April 6, 2016, to imprisonment for 33 months.
3. As a result, Respondent will be unable to be evaluated by FLA, Inc. and to comply with FLA, Inc. treatment recommendations.
4. In addition, FLA, Inc. will be unable to monitor Respondent's treatment while he is incarcerated.

5. Consequently, the parties request that those provisions be modified and that instead this Court order that “prior to Respondent’s reinstatement, Respondent shall be evaluated by FLA, Inc. and comply with all recommendations.”

7. Bar Counsel has spoken to Respondent who is not opposed.

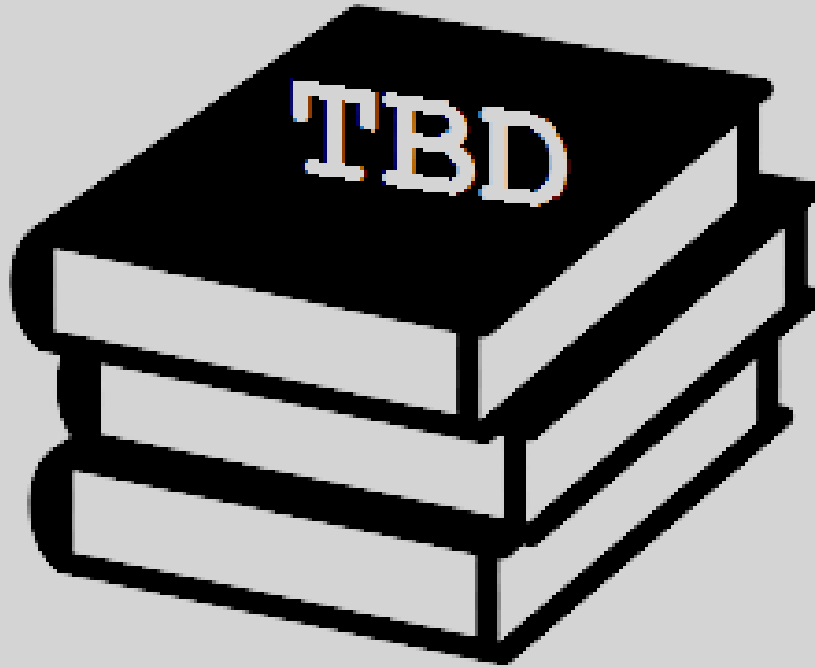
