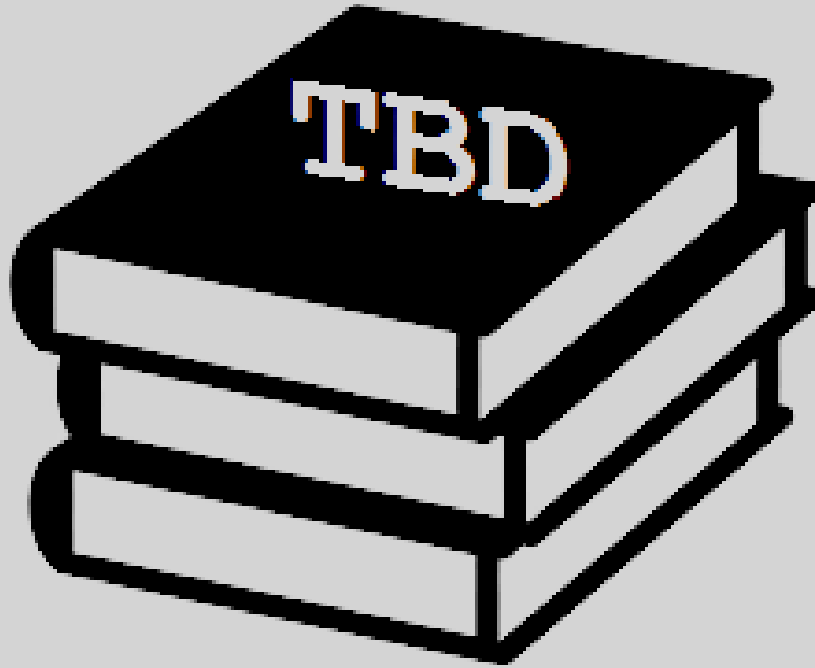

MOTION FOR CLARIFICATION

COMES NOW, The Florida Bar, by and through its undersigned counsel, and moves the Court to enter an order clarifying its final judgment herein in regarding The Florida Bar's Statement of Costs. In support of its motion, The Florida Bar would show:

1. On May 26, 2016, pursuant to Rule 3-7.13 of the Rules Regulating The Florida Bar, respondent and The Florida Bar filed its Joint Petition to Place Respondent on the Inactive/Incapacity List.
2. On May 27, 2016 The Florida Bar filed its Amended Motion for Costs in the amount of \$1250.00.

3. On June 16, 2016, the Florida Supreme Court issued an Order placing respondent on the Inactive/Incapacity List and awarded costs to The Florida Bar in the amount of \$1250.00.

4. Pursuant to Rule 3-7.13 of the Rules regulating The Florida Bar, being placed on the Inactive/Incapacity List is not discipline. Therefore, no costs should have been requested by The Florida Bar.

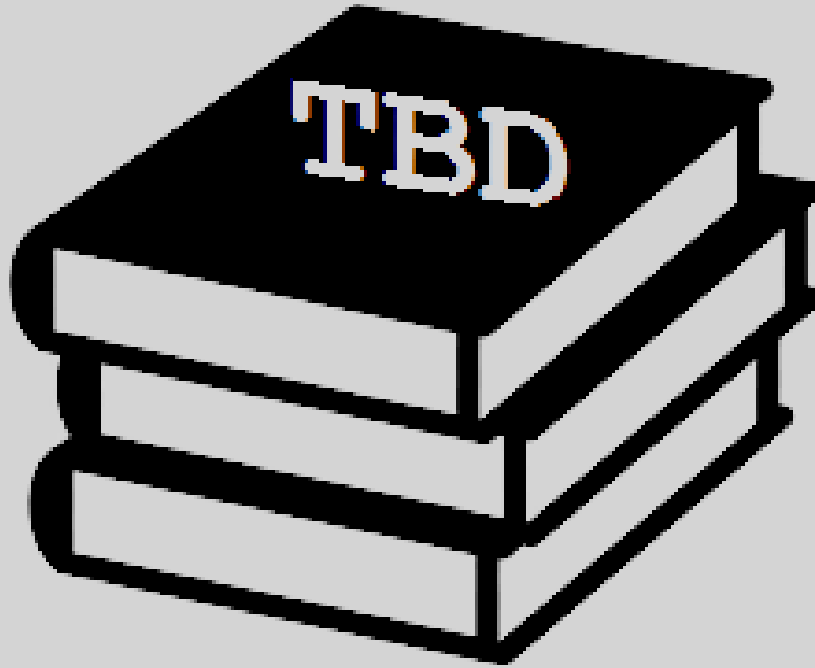
