**AGREED MOTION FOR CLARIFICATION AND TO CORRECT  
THE COURT'S JUNE 22, 2017 FINAL JUDGMENT**

Pursuant to Florida Rule of Appellate Procedure 9.330, Respondent, ALEX A. HANNA, moves this Honorable Court for the entry of an Order clarifying and correcting this Court June 22, 2017 Final Order. In support of this Motion, Respondent states as follows::

1. On June 22, 2017, this Honorable Court entered a Final Judgment, which states, “The petition to approve conditional guilty plea for consent judgment is approved”.

2. Respondent did not enter into a conditional guilty plea as part of a consent judgment. Instead, the Florida Bar filed a “Petition for Approval of Conditional Agreement for Diversion to a Practice and Professionalism Enhance Program”. A Conditional Agreement for Diversion to a Practice and

Professionalism Enhance Program that was executed by the parties was attached to the petition.

3. On June 2, 2017, the Clerk for the Florida Supreme Court issued an Acknowledgment of New Case which stated in pertinent part:

The Florida Supreme Court has received the following documents reflecting a filing date of 5/30/2017.

Petition for Approval of Conditional Agreement  
for Diversion to a Practice and Professionalism  
Enhancement Program

4. Respondent did not agree to conditionally plead guilty or otherwise in the petition or the conditional agreement between the parties.

5. Accordingly, Respondent respectfully requests that the Final Judgment be corrected to read:

The Petition to Approve Conditional Agreement for Diversion to a Practice and Professionalism Enhancement Program is approved and respondent's disciplinary case is diverted to a practice and professionalism enhancement program pursuant to Rule 3-5.3 of the Rules Regulating The Florida Bar, under the terms stated in the consent agreement.

Pursuant to the Agreement Respondent is Ordered to pay The Florida Bar, 651 East Jefferson Street, Tallahassee, Florida 32399-2300, for recovery in the amount of \$750.00, for which sum let execution issue.

6. The undersigned has consulted with the Florida Bar concerning the contents of this motion and the Florida Bar has indicated that it has no objection to the motion being granted.

**WHEREFORE,** Respondent respectfully requests that the motion be granted and that this Honorable Court enter an Order granting the motion and the relief requested herein and for such other further relief as this Honorable Court deems just and proper.

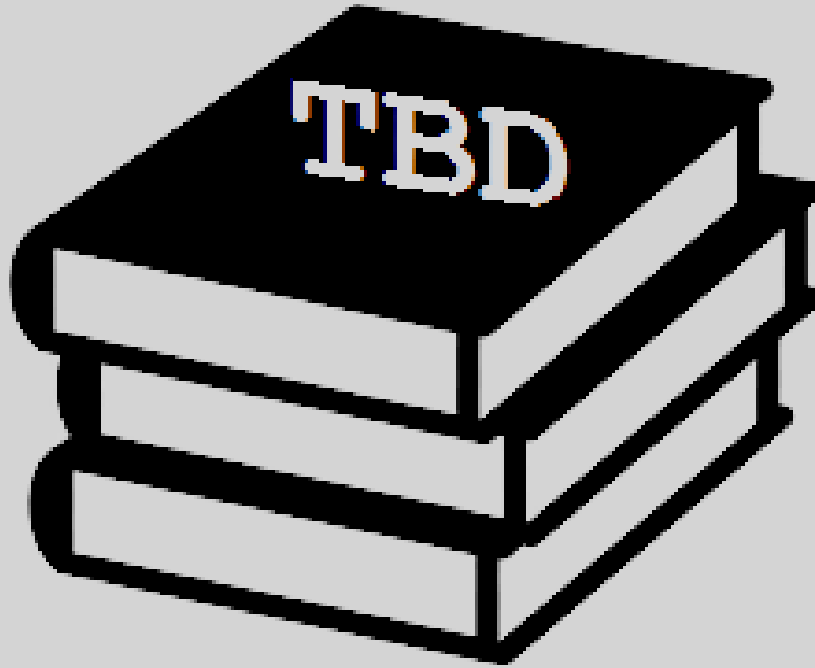
