THE PARTICULARS ARE (If additional space is needed, attach extra sheet(s)): I am a Black female with a Back/leg injury I received from this job. I was denied incentive increase for 1996 and 1997 in which whites on Building 8 received and were not eligible. Also Building 5 I worked over 11 years giving 110% of myself, never no thing but, "I am a troublemaker." I was rejected over 25 times for Supervisor I, some units interviewed me, other chose not to, some stated, "As you know, you did not get the job, but continue to apply," "we found someone best suited for the job," Thus, denying me as a single family to increase my family financial as many whites (single) and both white husband and wife. I continued writing management for falsification of timesheet. I was shamed by staff, tied on, staff was warned not to talk nor communicate with me as they were doing (job), continue harassment, retaliation, ridicule me when I complained, never acknowledged light duty work status from 4/94 - 12/24/96, then terminated on 12/3/97.

I will advise the agency if I change my address or telephone number and I will cooperate fully with them in the processing of my charge in accordance with their procedures.
