I had a watch order placed with the police. Since that encounter, I have received permit complaints from the Zoning Board as well as a visitation by two inspectors. The steps had been in place for two years prior to this visitation.



10. The acts alleged in this complaint, if proven, may constitute a violation of the following:


Sections 818 and 804f3A of Title VIII of the Civil Rights Act of 1968 as amended by the Fair Housing Act of 1988.
