I. PERSONAL HARM

On September 1, 1993, I was discharged from my position as a Clerk Typist II after being reassigned from my position as Clerk Typist II in the Police Department. I had been employed since January 23, 1989. *After failing typing test for Secretary.*

II. RESPONDENT'S REASON FOR ADVERSE ACTION

Captain Doug Muldoon, Division Commander, said I was discharged because I had failed the typing test. Mr. Muldoon said I was reassigned because my position had been deleted from the Budget.

III. DISCRIMINATION STATEMENT

I believe I have been discriminated against because of my Race, Black; Gender, Female; and pregnancy; for the following reasons:

1. Prior to my reassignment I had been on extended maternity leave due to complications during my pregnancy.
2. A white Clerk Typist II was transferred to a Secretarial Position but was not administered a typing test.
3. The typing test that I was administered was not the usual test of typing; but rather, it was a test of punctuation.
4. A white female, Ms. Debbie Schutt, is now occupying the Clerk Typist II position which was allegedly eliminated. I should have been reinstated to that position if it was not to be eliminated. *Secretary*
