

I. Personal Harm: During my employment with Respondent I was subjected to sexual harassment by Linda McClamma, Area Supervisor for Emeritus Corporation.

III. Discrimination Statement: I believe I have been discriminated against because of my Sex - Female, which is in violation of Chapter 760 of the Florida Civil Rights Act as amended for the following reasons:			
1. On April 1, 1998, I was typing for Linda McClamma. I had a question on what I was typing and addressed it to Ms. McClamma. She then put her hands around my waist. This made me very uncomfortable. Mark Danforth and Shirley Pecarraro were in the room at this time. Later that day I was again typing for Ms. McClamma. I asked her a question about the work, at which point she rolled her stool over to me and placed her right hand on my inner thigh. This made me extremely uncomfortable. Mark Danforth was in the room at this time.			
2. On April 10, 1998, I was talking with Carleen Weme in the hallway between the nurses station and the DON's office. Ms. McClamma came out of the DON's office after speaking with Shirley Pecorraro. She walked up to me and pinched me on the right side of my behind.			
I REQUEST TO BE AFFORDED FULL RELIEF TO WHICH I AM ENTITLED TO UNDER THE LAW(S).			
I will advise the agency if I change my address or telephone number and I will cooperate fully with them in the processing of my charge in accordance with their procedures.			
Under penalties of perjury, I declare that I have read the foregoing charge of discrimination and that the facts stated in it are true.
