Up until January 12, 2000, I was subjected to unwanted and inappropriate fondling, touching and sexual contact by my supervisor.

II. Respondent's Reasons for Personal Harm:

My supervisor told me that he was the reason I was employed with Respondent.

III. Discrimination Statement:

I believe I have been discriminated against because of my Sex - Female which is in violation of Chapter 760 of the Florida Civil Rights Act as amended for the following reasons:

1. Beginning in June 1999 through January 2000, Mr. Willie McDonald sexually harassed me. For example, when I asked for help on one occasion, Mr. McDonald told me I needed to be "sitting on his face." He has also attempted to grab my crotch area and has stuck his tongue in my ear. Although I requested to be moved to another area, my request was ignored. I ultimately resigned on January 12, 2000.

I REQUEST TO BE AFFORDED FULL RELIEF TO WHICH I AM ENTITLED TO UNDER THE LAW(S).

I will advise the agency if I change my address or telephone number and I will cooperate fully with them in the processing of my charge in accordance with their procedures.

Under penalties of perjury, I declare that I have read the foregoing charge of discrimination and that the facts stated in it are true.
