I. PERSONAL HARM: I WAS NOT GIVEN SERVICE AT I-HOP. AFTER CALLING AT 10:15 PM TO ASK ~~WHEN~~ THEM WHAT TIME THEY CLOSE. WE GOT THERE APPROXIMATELY 10:40 PM WELL BEFORE 11 PM. THE WAITRESS ZOE REFUSED TO SERVE US. I ASKED FOR THE MANAGER.

II. RESPONDENT'S REASON FOR PERSONAL HARM: ZOE (WAITRESS) YELLED OUT LOUD, YOU'LL NEED TO TURN OFF THAT FUCKING SIGN! THOSE FUCKING PEOPLE ARE STILL COMING INTO THIS FUCKING REST. TOM THE MANAGER APPEARED AND ACTED AS IF NOTHING WAS SAID BY ZOE. I SAID TO HIM SIR MY FACE IS BLACK NOT STUPID. THE WAITRESS SAID THE KITCHEN WAS CLOSED.

III. DISCRIMINATION STATEMENT: THEN THE WAITRESS ZOE STARTED YELLING, I AM NOT SERVING THAT NIGGER. I AM NOT SERVING ANOTHER NIGGER TONIGHT. WHO DOES THAT NIGGER THINK HE IS. I AM TIRED OF WAITING ON NIGGERS THEY MAKE ME SICK.

AFTER SHE STARTED CALLING ME A NIGGER THE MANAGER TOM REFUSED ME SERVICE. THEN HE SAID YOU NEED TO LEAVE BECAUSE YOU ARE CAUSING A DISTURBANCE. MR. COLMAN PAPPAS WHO IS WHITE IS A WITNESS TO ALL THE FACTS. TOM (MANAGER) TOLD ME I BETTER LEAVE BECAUSE HE WAS GOING TO CALL THE POLICE. I TOLD HIM CALL THE POLICE IF YOU HAD DONE NOTHING WRONG. BUT I WAS SO SHOCKED AND OUTRAGED BY THE WAITRESS AND THE MANAGER BEHAVIOR, THAT I WAS MORE DUMBFOUNDED THAN ANYTHING. I WALKED STUNNED AND
