**FINAL ORDER DISMISSING PETITION FOR
RELIEF FROM A DISCRIMINATORY HOUSING PRACTICE**

This matter is before the Commission for consideration of the Order Closing File, dated March 27, 2003, issued in the above-styled matter by Administrative Law Judge Claude B. Arrington.

Findings of Fact and Conclusions of Law

Judge Arrington's order reflects that Petitioner failed to appear at the scheduled administrative hearing in the matter. Consequently, Judge Arrington recommended the Commission issue a final order dismissing the matter.

We adopt the Administrative Law Judge's finding as to the nonappearance of Petitioner and conclude that Petitioner has failed to carry her burden of proof.

Exceptions

Neither party filed exceptions to the Administrative Law Judge's Order Closing File.

Dismissal


The Petition for Relief and Housing Discrimination Complaint are DISMISSED with prejudice.
