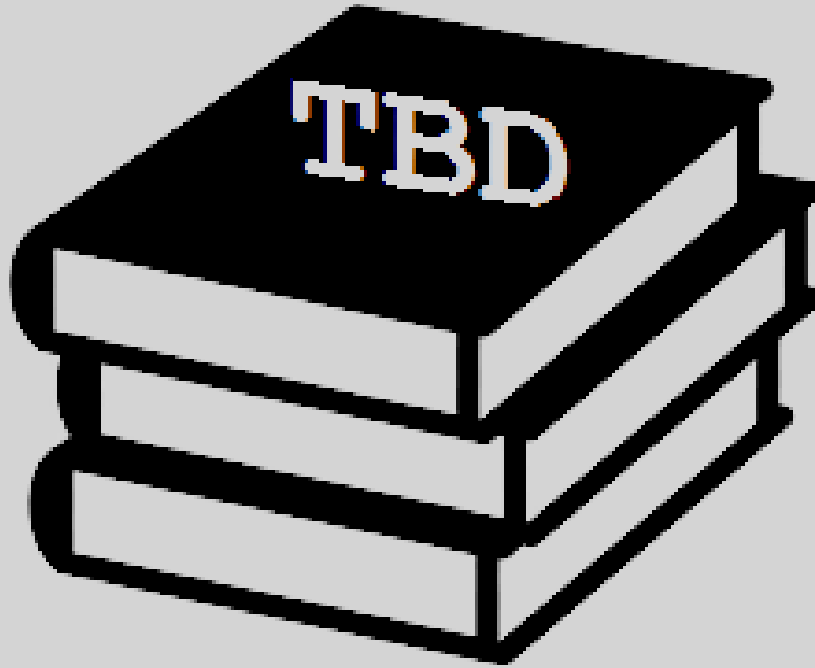

VNA Holding, Inc. is a subsidiary of AB Volvo a/k/a The Volvo Group, a publicly-owned Swedish corporation whose shares are traded on the Stockholm, Sweden, Stock Exchange and on the NASDAQ Stock Market.

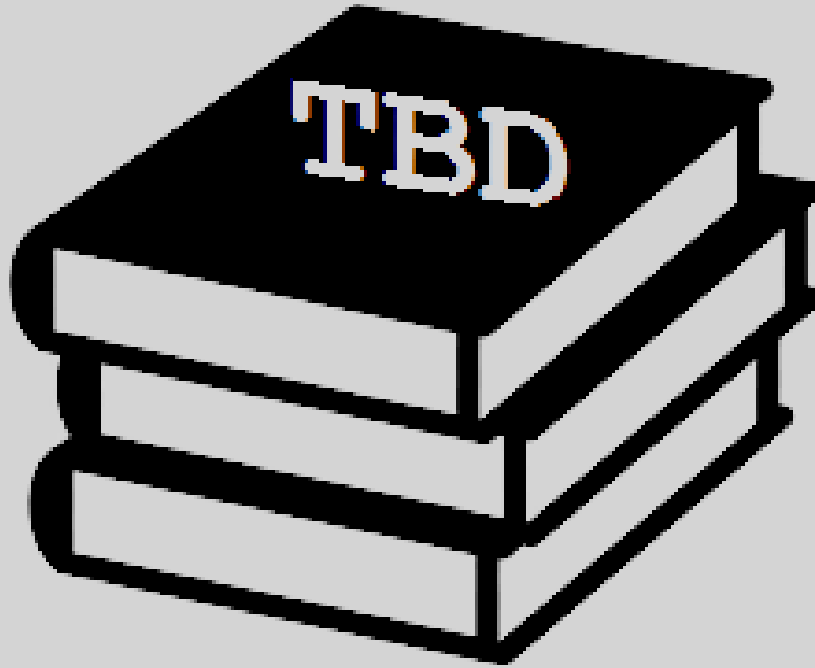
