Beginning 1/6/98 thru 7/18/98 I was subjected to a racially hostile environment created by the store (Milton store where I worked, 6281 Highway 90, Milton, FL 32570) general manager (Eileen McCray) and multi-store manager ("Scooter"). Remarks were regularly made about my interracial personal relationships and about my interracial child. I was told that I was hired because the store needed a white person on my shift. There was no one else to report this to other than those who participated in making the remarks--Eileen McCray and Scooter.

I believe I have been discriminated against on account of my race and interracial personal relationships outside of work. I believe my rights have been violated under Title VII of the Civil Rights Act of 1964 as amended and the Florida Civil Rights Act of 1992 as amended.

I request the full relief to which I am entitled under the laws.

I ~~was~~ NOT treated the same as the men, my co-workers - by our boss/supervisor Ernie Craig. I was always being asked sexual questions by him. He made me pay for things that happen under normal circumstances - that he did not make the men pay for. He talked to me very hateful when he was mad at me (which was a lot also) He didn't talk to them like that. He was told about a co-worker that stalked me - they (including supervisor) made fun of me about it for weeks. Our supervisor never even reported it. (In our handbook, that's reason for termination) He made me lose two days work and put me on 30 day probation over a phone conversation. He fired me because I asked him to stop yelling at me. He did not talk to the men like that.

I will advise the agency if I change my address or telephone number and I will cooperate fully with them in the processing of my charge in accordance with their procedures.
