**ORDER REMANDING PETITION FOR RELIEF FROM AN UNLAWFUL
EMPLOYMENT PRACTICE**

Preliminary Matters

On October 1, 2004, the Florida Commission on Human Relations issued its Order No. 04-137 in which it awarded affirmative relief from an unlawful employment practice to the Petitioner. In that order, it noted that if the parties were unable to reach agreement as to the remedy amounts for the unlawful employment practice found to have occurred and upon filing by the Petitioner of a Notice of Failure of Settlement, the Commission would remand the case to the Administrative Law Judge for determination of the appropriate remedy amounts in this matter. The FCHR Order No. 04-137 and Petitioner's Notice of Failure of Settlement are attached hereto and made a part hereof by this reference.

The Request for Relief and Award of Affirmative Relief from an Unlawful Employment Practice are remanded to the Administrative Law Judge for further proceedings consistent with the provisions of this order.
